Dear Mr. Reyna,

It has come to the attention of many in our community that misconduct has occurred regarding the upcoming election for Precinct 3 McLennan County Commissioner specifically the Republican primary.

The front page of our local newspaper, the *Waco Tribune Herald*, touted the headline: **Precinct 3 race features allegation of bribery**.

The article states that incumbent Mr. Will Jones offered two separate times to "pay (his opponent) the price of filing fee to drop out of the race." I am enclosing a copy of this article, assuming you have already read it, but as concrete evidence of this fact.

I am, as well, enclosing a copy of a Facebook post that Mr. Jones posted on January 8, 2016 which states:

"I offered to refund Benny's filing fee because I thought it was the right thing to do..." amongst other political reasonings to the jist of the fact that he may have more experience. Mr. Jones was a finance major at Baylor prior to his work as a stockbroker and investor. He touts that helping with the explosion in West was his proudest accomplishment. I and many helped with that effort and our proud of the help we gave. Was it not his job to jump to a need such as this? Isn't this decision as to takes this office up to the voters, not him, to decide?

Is it true that he, amongst other elected or appointed officials have to sign a statement upon entering office stating the following:

STATEMENT OF ELECTED/APPOINTED OFFICER (Pursuant to Tex. Const. art. XVI, ~ 1(b), amended 2001) I, _______, do solemnly swear (or affirm), that I have not directly or indirectly paid, offered, promised to pay, contributed, or promised to contribute any money or thing of value, or promised any public office or employment for the giving or withholding of a vote at the election at which I was elected or as a reward to secure my appointment or confirmation, whichever the case may be, so help me God.

If Mr. Will Jones did indeed sign this statement and, being that he is in his third year of his first four year term, many would assume that he has, he has formally sworn that he would not, indeed, offer money or anything of value to ensure his vote at the election. Is this not exactly what he is doing? By attempting to take out his opponent, he is basically buying his way in. Or, at least, this is very much the way most community members shall construe it.

I have contacted the Texas Ethics Commission and received counsel on this situation on what best to do. Contacting our County District Attorney was the advice I have received from them and others. Please see to it that justice is done in this matter.

Thank you for your time and consideration.

filing a complaint with the Texas Ethics Commission or with the McLennan County District Attorney's Office.

He told a large crowd at the McLennan County Republican Women's Club last week that he was anxious to get an opinion back from the ethics commission on his complaint. But. two days later, after consulting with an attorney in San Antonio, Matus said he decided not to pursue any avenue of complaint against Jones.

"I am not a lawyer, and nobody would give me any opinion about it." Matus said. "I did fill out the paperwork with the Texas Ethics Commission, but I decided not to send it."

Jones said last week that years in office. his offer to reimburse Matus his \$1.250 filing fee if he decided to drop out of the race was based on Matus' response to his question about why Matus wanted to run against him and what he wanted to accomplish.

Jones, 44, who is seeking his second four-year term. said Matus had no clear answer to his question.

Since that uptick in the race's public profile. the race has created few blips on the local political radar screen.

Jones, who has a finance degree from Baylor Uni-

Jones had been in office three months and 17 days when the West Fertilizer Co. plant exploded. destroying much of West. killing 15 people and injuring scores of others.

Jones worked with local. state and federal officials to bring the northern McLennan County town much-needed relief but also helped craft new legislation that expanded the definition of disaster to allow for the reappraisal of property damaged in any type of disaster declared by the governor.

"We lobbied very hard."

Jones said. "We got on our soapbox from West from the very beginning. That is one thing I am most proud of. I would do it all over again. I was still getting used to the way county government worked, and my learning curve went through the roof."

Matus, who has been an auto repair instructor at Texas State Technical College for 29 years, is a native of West and a former West City Council member. He said he thinks he would complement the long line of Precinct 3 commissioners who traditionally have been from West.
